WITNESS THIS AGREEMENT this _____ day of _____, between REDWING FARM and _____ (mare owner or lessee) is for the breeding of an American Saddlebred horse by use of transported fresh cooled for frozen semen. The terms and conditions are as follows:

1. The STALLION OWNER (Redwing Farm) will send the MARE OWNER transported semen (fresh cooled or frozen as requested by mare owner).
2. The MARE OWNER shall use the transported semen for breeding only the following mare and no other:

3. The MARE OWNER shall pay the Stallion Owner a service fee of **\$2500.00**. The service fee is due **PRIOR** the first shipment of semen.

4. A payment of **\$300.00** shall accompany the return of this contract by the Mare Owner to the Stallion Owner. This fee includes the collection and processing of two fresh cooled semen shipments. This fee does NOT include Federal Express fees, airfreight, and/or courier fees. If additional shipments are required, there will be an additional collection and processing charge of \$150.00 per shipment, plus shipping charges. Frozen semen is only sent by Federal Express and the cost of shipping and return of the container is estimated at \$325.00. Frozen Semen is stored at and will be sent by Equine Medical, Columbia, Mo. EQUINE MEDICAL SERVICES (573-443-4414) WILL NEED A CREDIT CARD NUMBER PRIOR TO THE SHIPPING OF FROZEN SEMEN.

All Federal Express fees, air freight (airlines) charges and/or courier fees pertaining to the shipment of the shipping container (and ALL of its contents) to and from the breeding facility are the responsibility of the mare owner.

All requests for semen shipments shall be filled as received, subject to availability of semen. We make every effort to meet shipment orders. DESIGNED IS COLLECTED THREE DAYS A WEEK- MONDAY, WEDNESDAY AND FRIDAY. Semen orders must be placed by 9PM CST the day preceding the collection day.

5. In the event the above named mare aborts, gives birth to a dead foal or gives birth to a foal which fails to stand and suckle, then a return privilege extends only for the next breeding season. If the stallion named in this contract is deceased or the Stallion Owner is other wise unable to provide semen from such stallion at the time of the return privilege is valid-Redwing Farm may provide a comparable alternate stallion.

6. Breeding season is from March 1 to August September 1. We do not collect the week of the Kentucky State Fair. After 9/1-we will collect-but orders must be placed 24 hours prior to collection.
